Title: Flexi-School Audit – Winter 2017

Purpose

To evaluate and inform TQC of compliance to Flexi-School Policy and Ordinance for the Payment of Fees and highlight issues.

Executive Summary:

The summary of the 201702 Offerings in Tables 1 & 2 of the Appendix as at 7th Aug 2017 are as follows:

- 1. Total Number of Courses Offered: 24¹
- 2. Total Registrations: 911²
- 3. 83.1% or 757 students paid their fees
- 4. 16.9% or 154³ students have yet to pay their fees
- 5. 58.3% or 14 courses met the minimum numbers
- 6. 41.7% or 10 courses didn't meet the minimum numbers
- 7. 29.2% or 7 courses met the minimum learning hours
- 8. 70.8% or 17 courses didn't meet the minimum learning hours
- 9. The largest improvement in unpaid fees monitoring was seen in FSTE at 66% followed by FALE at 56% and FBE at 25%

Issues

- 1. Non-compliance to Flexi-School Policy:
 - a. Minimum number requirement not adhered to in some courses
 - b. Students are still being accepted to class without paying fees and undertaken assessment(s)
- 2. Courses starting at different dates makes tracking, administration and fee reconciliation of the flexischool process difficult
- 3. Deadlines are based on the first flexi-school course that is offered e.g. online withdrawal is open till the 1st Friday of lectures of the first flexi-school course i.e. any withdrawals for courses starting thereafter have to be backdated to the course withdrawal deadline of the first flexi-school course

Recommendation(s):

It is recommended that the:

- 1. Start and End Dates be determined so that registration is done online irrespective of location:
 - a. all Winter FS Courses start on Monday of Study Week of Semester I
 - i. ends 5 working days prior to Monday of AA and Registration Week over 5 weeks
 - this allows 10 working days for finalising administrative issues before Sem. II Lectures commences
 - b. split the current Summer Flexi Term of VXYZ04 into two terms namely:
 - i. VXYZ04
 - <u>Start</u> Monday after all Sem. II Results have been uploaded and <u>End</u> 31st December
 - ii. VXYZ05
 - Start 1st Working Day in January and End 31st January
- 2. Flexi-School Policy be amended to reflect approvals in APC, TQC and Senate.

Financial Implications: (costs involved if any)

The minimum of 4% surplus for course offerings was not achieved in 41.7% or 10 of the courses offered as in Table 1 and 16.9% or 154 students have yet to pay their fees as at 7th Aug 2017.
