CALLS FOR APPLICATIONS: CERTIFICATE IV IN RESILIENCE

(Climate Change Adaptation and Disaster Risk Reduction)

The Pacific-European Union Marine Partnership Programme (PEUMP) at the Institute of Marine Resources (IMR) in collaboration with USP Pacific TAFE is pleased to invite applications from marine and fisheries management personnel in **Fiji, FSM, Kiribati, Palau, PNG, Solomon, Tuvalu, Timor Leste and Vanuatu** for the Certificate IV in Resilience programme. This programme is to be offered by cohort basis (20 weeks) from 10th February to the 26th of June, 2020. This will also include a 2-week face-to-face session in Fiji (1 in Week 9 and 1-week in Week 20).

DESCRIPTION

This programme reflects the attributes required by individuals to continue to engage in the workforce and/or to assist, coordinate and lead teams at community and national level. The skills sets derived from the units of competencies prepares individuals in identifying Work, Health & Safety (WHS) hazards, performing risk assessments at work sites, project planning & implementation, undertaking Costs & Benefit analysis for projects and understanding the institutional frameworks set in place at Local, National, Government, Regional and International levels for a particular field of Resilience (focusing on the Marine & Fisheries sector). This programme also provides a pathway to undertake roles that will assist in creating awareness and decision making processes related to vulnerability, climate change adaptation, mitigation and disaster risk reduction with focus in the marine & fisheries area.

CAREER OPPORTUNITIES

Job roles and titles vary across different industry sectors. Possible job titles relevant to this qualification include: Climate Change Advisor, In-country Coordinator, Project Coordinator, Consultant on Climate Change and Resilience, Climate Change Policy Advisor.

ELIGIBILITY/ADMISSION REQUIREMENTS

To be admitted to this programme, a person:

- (i) Pass in Senate recognised year 12 with English and a minimum of 2 years of relevant work experience; or
- (ii) Met the mature student admission criteria; or
- (iii) Completion of Certificate III in Resilience: or
- (iv) Any special case where the above requirements are not met can be approved by the Director or nominee on case by case basis
