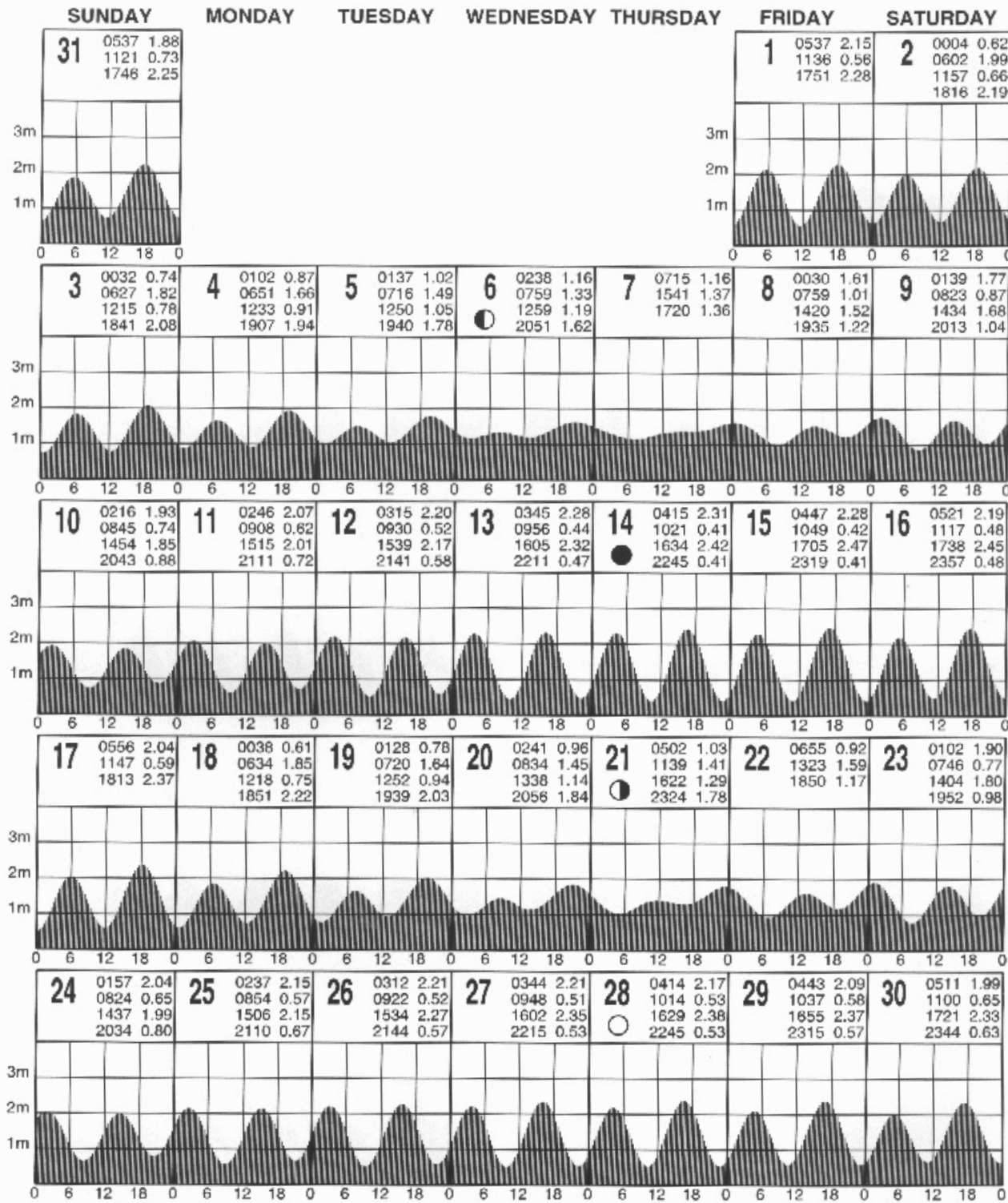

**Tuna Management.**

A meeting was held on 28 July between Fisheries heads from the Nauru side and visiting consultants from the Forum Fisheries Agency (FFA).

Present at the one-day meeting were Minister, Hon. Marcus Stephen MP; Chairman Hon. Godfrey Thoma MP; CEO Anton Jimwereiy; R&D Manager Peter Jacob; Mr. Len Rodwell (Manager Economics & Marketing – FFA); and Minoru Honda. The latter, Mr. Honda is from the Overseas Fishery Co-operation Foundation (OFCF) of Japan on attachment to FFA.



The purpose of the meeting was to brief the Minister and Chairman of the request submitted by NFMRA to FFA for the development of a Tuna Management Plan for Nauru.

The proposed 'Tuna Management Plan' takes into account the need to:

- (i) Effectively manage and conserve the tuna fisheries resources through regulating the fishing activities within Nauru's EEZ (Exclusive Economic Zone) and in conjunction with regional and international management and conservation measures of the tuna resources within the western and central Pacific Ocean; and
- (ii) To develop a commercial tuna/fishery industry in Nauru.

FFA is assisting Nauru in drafting the Tuna Management Plan for eventual submission and consideration by the Government of Nauru.

## Fish Food Consumption Survey



Visiting OFCF representatives here to develop the FESAP workshop, Fisheries Expert Mr. Keiichi Sato and Consultant from the Fishing Engineering Inc. Mr. Toyomistu Terao also conducted a tuna survey during their fact-finding mission. The survey carried out on only 20 people, consisted

of various questions based on the local consumption of fish food, especially tuna. A specification of the survey is for the selected interviewees to come from varied parts of the island and fishing activities.

Conducting the survey on behalf of the visiting OFCF representatives were Nauru Fisheries Coastal section, Ms. Margo Deiyee and Ms. Ebelina Tsiode. The FESAP delegates sponsored transportation and time of the interviewers allocated to this survey.

## Nauru Represented at International Symposium

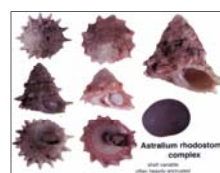
The International Coral Reef Symposium conducted every four years was held from June 28 to July 2, 2004. This year marks the 10th anniversary since its' establishment and Japan's capital, Tokyo was the host country. This particular convention invites the participation of scientists, researchers, conservationists and donors interested in the sustainable management of coral reefs.

Ms Deiyee depicted the current status and phenomenal occurrences of Nauru's coral reef ecosystem through a poster produced prior to her Japan trip.

## Zoologist Visits Nauru

Visiting from the Zoology University of Florida, Ms. Lisa Ann Kirkendale a Ph.D student sponsored by NFMRA arrived on 29 June 2004 to conduct a local data and specimen collection of Turban snails for research purposes. Ms. Kirkendale conducted her research with the assistance of Ms. Ebelina Tsiode and Coastal section, during which she collected turban snail (Common name: periwinkle) and water samples both from the reef and the open



water. Several dives were organized during day time and night to enable her to collect specimens.

Ms Kirkendale reportedly found most of the specimens required for her research and due to pressing schedule, left funds and specific instructions for the postal dispatch of some of the specimens, which had special packaging requirements. A report of her findings will be submitted to the Authority in due course.

## PACIFIC ISLANDS FORUM FISHERIES AGENCY VACANCIES

Applications are invited for the positions of *Corporate Services Manager (CSM)*, *Manager Economics & Marketing (MEM)*, *Projects Economist (PE)* with the Forum fisheries Agency (FFA). Applications from both men and women are sought. FFA is a regional organisation with a staff of approximately 52, based in Honiara, Solomon Islands. It is responsible for assisting its 16 member countries and one, territory member co-ordinate tuna fisheries management policies and promotes the development of their tuna fisheries resources.

**Corporate Services Manager (CSM)** has management responsibilities for all corporate service functions within FFA, including financial and management accounting, human resource management, staff travel, asset management, office and security services. The position reports to the Deputy Director on routine matters and to the Director in some instances. Applicant should have appropriate tertiary qualifications in accounting/commerce/business administration or another relevant corporate services discipline. Member of a recognized professional accounting body as a professionally qualified accountant (CPA or equivalent) is desirable. Applicant should have the ability to contribute to the FFA management team, advise Executive Management and other Division heads on corporate services issues.
