### Message from the Minister

This month triggers more on-going activities within the Nauru fishery sector. In-country workshops and assistance programs fill the Authority's timetable yet again with the ever-present expert support from the Forum Fisheries Agency (FFA), Overseas Fishery Corporation Foundation (OFCF) and the Secretariat of the Pacific Community (SPC) in the form of specialist assistance to Nauru's long-line vessel fishing operations and the planning and preparations for the deployment of FADs within Nauru waters. The SPC programme allows for training of fisheries personnel and the local public.

Occasionally, Nauru fishery extends its role into scientific data compilation within the regional area. The regional agent, the Forum Fishery Agency, organizes this through its *Observer Training Program*, which this month involved the participation of two of Nauru's citizen to the course. In-depth coverage of these stories will be found within the pages of this edition of Mwin-Oañan.

Nauru was represented at the annual PNA and FFC Meetings held in Majuro which also incorporated the first FFC Ministerial Meeting. Nauru will be host country to this annual meeting in 2006.

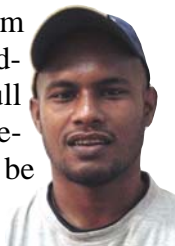

### NFMRA Observer Candidates Pass with Distinction.

Early this year the Forum Fisheries Agency (FFA) advised Nauru that two full time observers were required from each member country to be assigned on fishing vessels licensed with FFA.

Nauru Fisheries and Marine Resources Authority advertised with Nauru media of FFA's requirements and more than seventy applicants applied. An examination supplied by the SPC and FFA narrowed the list to a total of ten. The successful ten then were interviewed by a Fishery panel consisting of David Uera (Coastal), Ace Capelle (Oceanic) and Terry Amram (Administration Manager). Although the other eight did not succeed, they will also be required when the FFA needed more Observers.

After being informed by Fisheries of their success, Elton Clodumar (photo left) and Sean Halstead (photo right) were immediately sent to an observer training program that was jointly organised by FFA / SPC and held in Pohnpei. The training course consisted of National Oceanic Atmospheric Agency's (NOAA) De-



hooking Technique & Sea Turtle Safe Handling and Release Guidelines, Forum Fisheries Agency & Secretariat of the Pacific Community's (FFA/SPC) Regional Observer Training Certification Standards.

After completing the training course with flying colours - Sean commented.. "There were 14 trainees from various islands, 3 dropped out leaving 11. My colleague, Elton, was first in the exams and I came second." This achievement being the first made by any previous Nauruan representatives.

Due to their impressive achievement, the FFA advised the two newly certified observers before returning that their placements will be given first priority. Preparations are underway for the expected observer placements that will take a duration of 4 to 6 months on selected fishing vessels.

Elton and Sean's effort and achievement should silence the critics who thought that nepotism was involved in their selection. They have set high standards for Nauruans to follow. On behalf of NFMRA, Mwin Oañan conveys its congratulations to Elton and Sean.

## SPC FADs Deployed

The FADs that were donated to Nauru from SPC early this year have been deployed successfully. This success is due to the co-operation and team work of the NPC Marine Gang and Fishery's **Coastal and NFC team** led by *Coastal Fishery Development Officer* Ricky Starr and Capt. Michael Quadina aboard the NF6 (AB II). The FADs were deployed at the selected site recommended by SPC Master Fisherman William Sokimi.

## OFCE Returns

Nauru Fisheries again welcomes Japan's Overseas Fishery Cooperation Foundation (OFCE) who returned to oversee the complete the overhauling of NFMRA's long liner, Victor Eaoe II (NF5). The four man team led by Mr. Katsuji Fujita arrived late April and left early May, 2005.



Although unable to complete their tasks on NF5 due to the non-arrival



of its parts, the team met with Fishery's Management - Peter Jacob, Terry Amram and Charleston Debye - and discussed NFMRA's needs for 2006. Mr. Fujita is hopeful that parts needed in the completion of NF5 will arrive in June when Minoru Hatano and his team, arrives in Nauru for the signing of the MOU 2006.

## Chapman's Research

Lindsay Chapman who is the Fishery Development Advisor with the Secretariat of the Pacific Communities (SPC) conducted a consultancy evaluation on NFMRA's commercial entity, the NFC. On this SPC visit Mr. Chapman presented a feasibility report on the operations of NFC to date. Assisting Mr Chapman's research were NFC Management and the Accounts department. An impromptu meeting was then called for Fisheries Heads of Departments and the Board of Directors for Mr Chapman to present findings and recommendations for the future development of NFC. Chapman's recommendations is mainly to improve NFC's operations



which includes; 1) cutting costs, 2) increase revenue, 3) restructuring organisations structure, 4) streamlining accounting process and 5) greater autonomy by NFC from NFMRA. Present at the meeting were Hon. Marcus Stephen MP (Chairman), Hon. Cyril Buramen MP (V/Chairman), Peter Jacob (A/CEO), Terry Amram (Admin/Manager), Charleston Debye (Operations Manager), Ellington Dowabobo (NFC/GM), Margo Debye (A/Research & Development Manager), Vivek Varshnay (Finance Manager) and Allan Debao.

## Master Fisherman's Long Haul in Nauru

William Sokimi, Secretariat of the Pacific Community's Master Fisherman will be in Nauru for two



months to assist NFC and Coastal sections develop fishing skills.

William's arrival was instigated by the feasibility report recently conducted by Lindsay Chapman (SPC Community Development Officer) on the

development of both NFC and NFMRA.

Sokimi's first few weeks will be spent on training of NFC fishermen in long-line fishing which would

involve spending more than 5-6 days out at sea.

Also included in the programme is *Safety at Sea* which emphasises survival skills and initiatives for

minor on-board vessel problems. William said.... "You can tell a school of fish by the way a flock of birds hovering over it. Birds flying low and fast could mean Skipjack, birds hovering high could mean big Yellow Fin Tuna or other big species."

A similar training programme will be conducted for the local fishermen.

## Nauru Represented at FFC Meeting in Majuro.

The annual meetings of the Parties to the Nauru Agreement (PNA) and the Forum Fisheries Committee (FFC) were held in Majuro, Marshall Islands from 31st May to 10th June 2005.

Hon. Marcus Stephen (*Chairman*) and Peter Jacob (*A/CEO*) of NFMRA represented Nauru at the PNA Annual Meeting sessions. Hon. Godfrey Thoma (*Minister*) and Hon. Marcus Stephen, accompanied by Anton Jimwereiy (*Adviser*) and Rubin Tsitsi (*Nauru Representative-Majuro*) attended the annual meeting of FFC.

Major outcomes of the PNA Meetings were: **1)** the convening of a PNA Ministerial Meeting in October 2005



to sign off the proposed Vessel Days Scheme (VDS); **2)** to discuss matters concerning the Fisheries Partnership Agreement with the EU (*European Union*); and **3)** issues concerning the WCPF Commission.

Findings highlighted in the annual FFC Meeting and the first formal annual Ministerial FFC Meeting were: **1)** the approval and adoption for an annual FFC Ministerial Meeting under the approved FFA Strategic Plan 2005-2020; **2)** the endorsement for increased funding arrangements for the Pacific Islands Forum Fisheries Agency (FFA) to support the FFA Strategic Plan 2005-2010; and **3)** endorsement and support for Nauru to host the next annual FFC Ministerial and officials meeting in 2006.



## Local Schools Visit NFMRA

In its endeavour to promote marine awareness to the general populace, the Fisheries accepted the request of a general visit from Kayser Infant and Yaren Primary schools to its establishment.

The Yaren Primary School (*photo top left*) consisting of 90 children and 3 teachers conducted their visit to the



Anibare Boat Harbour and office complex and then the Nauru fish market on Thursday 5th May. Despite the number of visitors to the sites, the day was filled with informative and educational experience of the complexities and various activities within the fishing sector. An alternate visit of 45 children to the Anibare site and Fish market complex included the presentation of *food safety/handling and processing to more complex topics of mechanical and safety issues required in the running of Nauru's long-line vessel, the Austin Bernicke II.*



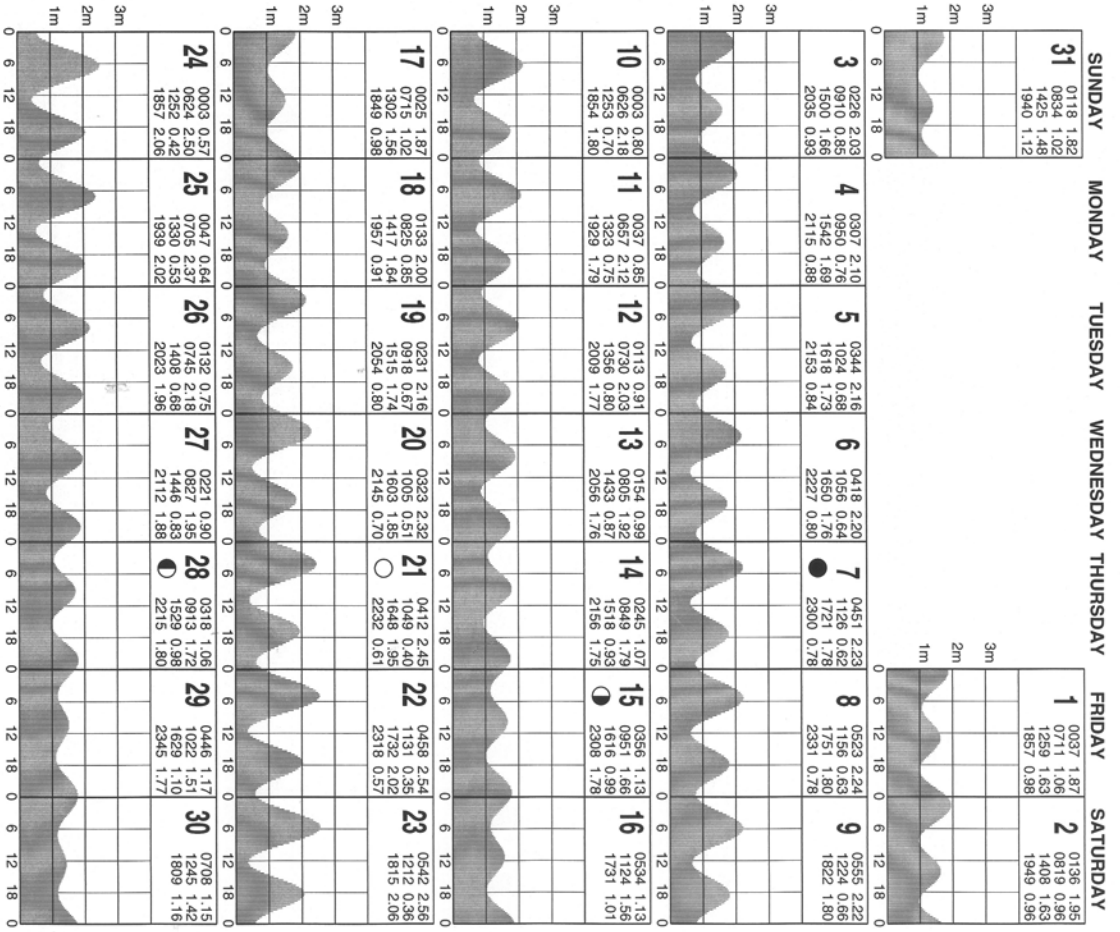

Tide gauge zero is 7.2929 metres below NAUI



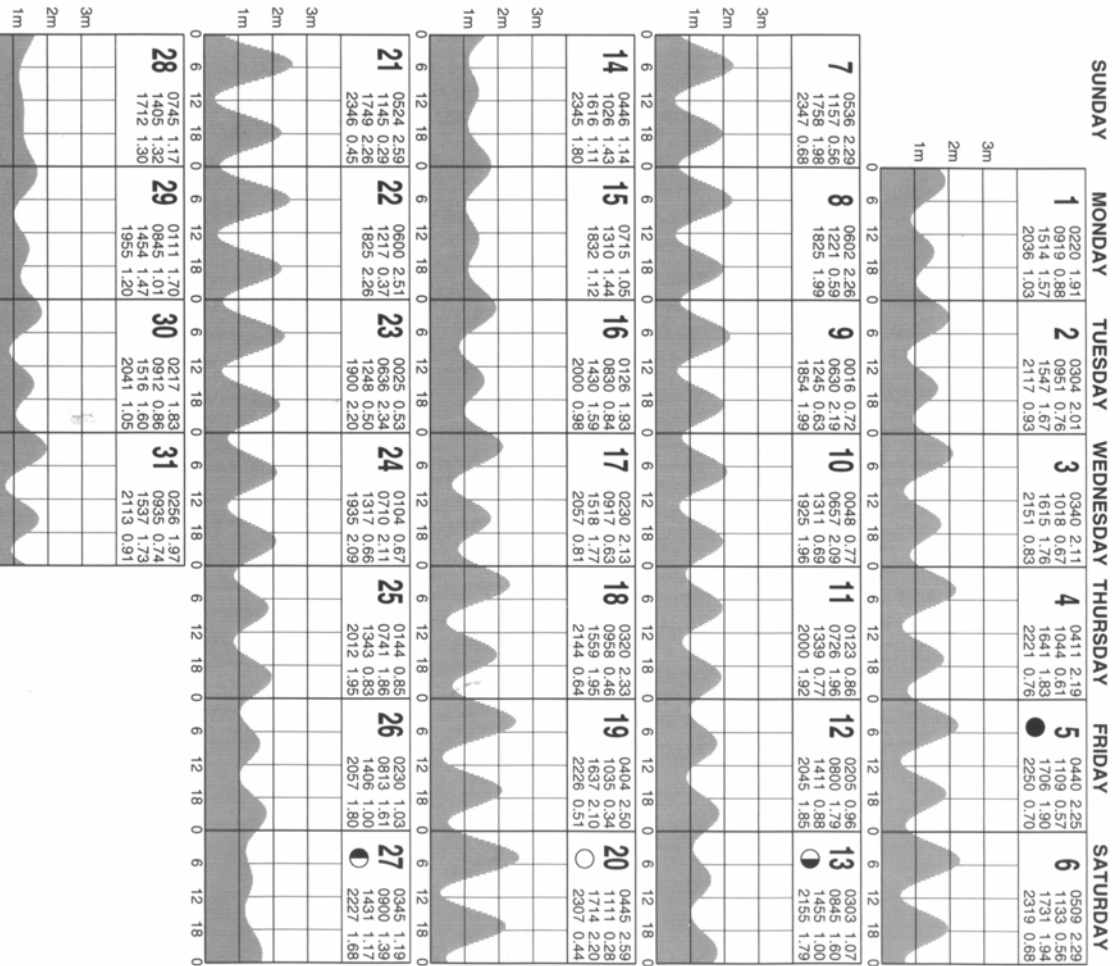
